More on Jefferson Parkway or alternates. (I'm posting rather than following up since I can't enclose a PDF otherwise. Two more images will be posted separately since "Document" postings apparently don't permit image postings as well)



No surprise: misinformation, fearmongering, and suspicion can derail a legitimate project for purely political reasons. As I have stated elsewhere, I am personally ambivalent about the Jefferson Parkway, but feel it is important to have reliable information about Rocky Flats contamination in making decisions.

I enclose a preliminary report on the findings of all the Jefferson Parkway soil sampling, including a few samples from Dr. Michael Ketterer, currently being paid by the Rocky Mountain Peace and Justice Center to hunt for 'hot particles'. Apart from the single sample associated with a 'hot particle' 466 soil samples (mostly along the Parkway right of way), all are in compliance with what was a negotiated (not a health-related) standard of 10 pCi/g.

For those curious about alternate routes, I also will post separately a map of plutonium and americium levels as of 2006, as measured by the DOE. (Much more information and sources are at <u>rockyflatsneighbors.org</u>. (<u>http://rockyflatsneighbors.org</u>), or you can contact me directly.)

1. If you decide to worry about soil plutonium disturbed by construction, levels along Indiana adjacent to the Refuge are distinctly higher than along 93 on average. On the other hand, all measured levels represent a very small risk in comparison to similar natural radioisotopes already present naturally in Front Range soil (which are presumed to contribute NO extra risk, since they are background). Measurements within the Refuge through the mid-1990s indicate that surface soil levels of plutonium have been declining at rate of about 1% per year, presumably as it sinks deeper into the soil.

2. If you have not read CDPHE documents about Rocky Flats, you should. (They concur with DOE documents and estimates, but are mu**Chats** readable.) The incremental cancer risks from plutonium in soil around the Refuge is very low, in the

range of 1 in a million, at least 100,000 smaller than lifestyle-related sources.

3. 4. Any construction around the Refuge will be subject to intense scrutiny by a number of groups, and dust control (see, for example <u>https://dec.alaska.gov/air/anpms/dust/control-techniques-list</u> (<u>https://dec.alaska.gov/air/anpms/dust/control-techniques-list</u>)) is not rocket science.

If you feel that traffic on Indiana is already a problem, a reasonable estimate for how long it would take to develop an alternative to the Jefferson Parkway is how long it has taken for the Parkway to be proposed and the political infrastructure (the Parkway authority and financial commitments by local municipalities) put in place. This is probably 4-5 years at least.
